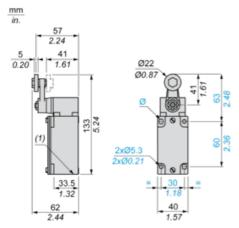

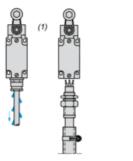

#### Position of Cable Gland

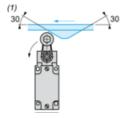

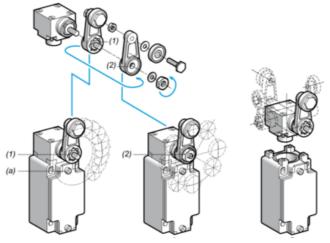

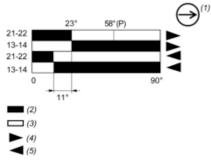
